1) Welcome

President Emma Erdahl called the meeting to order at 7:05 p.m.

2) Council Member Lisa Goodman

Council Member Goodman gave the following announcements:

- No Lunch with Lisa in March
- Lunch with Lisa will resume on April 28 at 12 p.m. via Zoom. Special guests are Kelly Matter and Emily Bastian from Avivo. They will be sharing an inside peek into the innovative and newly created Avivo Village, an indoor community of 100 secure, private dwellings, or "tiny houses," created to provide shelter to individuals experiencing unsheltered homelessness.
- Zoning Board of Adjustment approved the variance at 2833 E Lake of the Isles Pkwy.
- Hennepin Avenue reconstruction designs are available for public comment. Council Member Goodman is a proponent of delaying construction due to COVID, civil unrest, and utilities construction.
- The City of Minneapolis is sending out information and updates regarding the Chauvin trial. The City's Joint Information System will be sending out regular

communications with the most recent and up-to-date information, including information that can be copied and pasted into neighborhood newsletters and social media. The City is adding all neighborhood organizations to this list. NCR will host weekly meetings with neighborhoods, Wednesdays from 6-7:30 p.m., from March 10 - June 15 (the frequency and time may change).

- COVID-19 emergency rent and utility bill assistance is available for those that
 qualify. While you can't be evicted for not paying rent during Governor Walz's
 executive order, rent is still due. When the order is lifted, people owing unpaid rent

8) Built Environment and Transportation Committee (BET)

BET Committee Chair Andrew Degerstrom gave the following report:

• The Executive Committee adopted the following resolution regarding a variance request at 2833 E Lake of the Isles Pkwy:

Resolution 2021R-10: Resolved that EIRA recommends to the City of Minneapolis that it approve an application for a variance from the front yard setback requirements for the construction of a porch and staircase for the two-family dwelling located at 2833 E Lake of the Isles Pkwy based on the following findings:

1. Practical difficulties exist in complying with the ordinance because of circumstances unique to the property. The unique circumstances were not

- created by persons presently having an interest in the property and are not based on economic considerations alone.
- 2. The property owner proposes to use the property in a reasonable manner that will be in keeping with the spirit and intent of the ordinance and the comprehensive plan.
- 3. The proposed variance will not alter the essential character of the locality or be injurious to the use or enjoyment of other property in the vicinity. If granted, the proposed variance will not be detrimental to the health, safety, or welfare of the general public or of those utilizing the property or nearby properties.

Further resolved that the Chair of the Built Environment and Transportation Committee is authorized to write a letter to that effect.

- The South Hennepin Reconstruction Stakeholder Advisory Committee is working with neighborhoods to send out a joint postcard regarding the listening session and where to seek more information.
- There will be no BET Meeting in March.
- April BET meeting will include a presentation on the Hennepin South reconstruction project from City of Minneapolis project staff and will include an opportunity to ask questions and provide feedback.
- The February BET meeting included presentations on the following:
 - Bde Maka Ska Refectory Rebuild project: Daniel Elias, Minneapolis Park & Recreation Board.
 - 2021 Improvements at The Mall: Colleen O'Dell, Minneapolis Park & Recreation Board.
