Questions: Erlandson - can you share more about the encampments? Goodman - city doesn't have a policy on homeless encampments. Hennepin County allocates money and is their body of work. The city gets involved when encampments are on city property, example of Greenway encampment last summer. Working to address the 30 encampments in the city with resources, etc. Lauture - what is City Council and the MPD doing to address public safety, specifically on Hennepin Ave. and Lake St.? Goodman - recommend inviting Inspector Katie Blackwell from MPD to the board meeting. Offered an amendment for hot rodding, asked the legislature to review the penalties for this kind of behavior.

9. Open Forum

Accetura - does anyone know where construction is at for Grace Church? Is this an option for committee meetings?

Accetura - Outreach and Engagement Committee met last month and approved the development and execution of a survey project. Objective is to learn what EIRA residents know and value about our events and other initiatives. In order to maximize the number of survey respondents, we are planning to partner with neighborhood Block Captains and ask them to distribute the survey. We need your help to collect a list of Block Captains. EIRA's email newsletter list of approximately 800 does not reach most of the 3,200 residents in our neighborhood. After discussion, we concluded that the best way to reach people is to partner with East Isles Block Captains — individuals who organize the annual National Night Out block parties. The 5th police precinct has Block Captains on file, but names cannot be shared due to the city's data privacy act. That's why we are reaching out to you. There are 33 Block Captains in East Isles. We would appreciate it if you could please share the name and email address of your Block Captain as well as any others you may know through friends or family who live in our EIRA community. Sandy Nelson, an Outreach and Engagement Committee volunteer, has offered to lead and manage the project from inception through completion.
